### OVERVIEW

The specialized, inter-professional care of neonates requires ongoing medical education. The goal of the 19th Annual New York Regional Neonatal/Perinatal Symposium is to provide cutting-edge information about neonatology by teaching physicians, nurses, nurse practitioners, residents and fellows the pathogenesis of various disease states that affect newborns, and how the development of new therapeutic approaches (pharmacologic and technologic) can influence care outcomes. A recent needs assessment identified the following areas in knowledge, competence and performance that we plan to address: recent advances in management of various neonatal diseases; recognition of neonatal delivery-room trauma; how to diagnose, treat and improve long-term outcomes of preterm infants; and the importance of proper documentation and standard neonatal practice from a medico-legal perspective. The agenda includes didactic lectures, case presentations, an audience-response system and interactive discussion of the topics presented by expert faculty from around the country.
